DISCUSSION:

ACTION ITEM:

- Karl requested that NO MATTER HOW MINOR the acts of theft or vandalism, residents should call Police to report the incident. He said that the priority for patrol cars is determined by the number of such reports -- the more incidents are reported, the more police cars will patrol the neighborhood.

NEW STANDING COMMITTEES

- New President Jay Fenner asked residents to help him create new standing committees and volunteer to be on those committees. Following are the purpose of each new committee and it's members:

DEED RESTRICTIONS: Keep up with Deed Restrictions, keep a current copy; provide a copy to each new residents. Karl Muench

SOCIAL COMMITTEE: Schedule a social event, Association meetings and Board of Directors meetings (twice a year, alternating seasons on latter two). Collect and maintain telephone directory for the neighborhood. Charlotte Howard and Fidel Lucia

SECURITY/POLICE: Track statistics of incidents; disseminate information on contacting police and notifying other residents about incidents. Jimmy Clemens (Chair), Darla Lorber for Las Palmas, Jimmy Clemens for Norfolk and Robert Mitchell for Portsmouth.

COMMUNICATIONS: Develop a newsletter and an Association Website. Margaret O'Brian-Molina.

TRAFFIC MANAGEMENT: Cut-through traffice, parking situation with Movie Theatre going in; closing off Las Palmas. Jay Fenner (Chair), Robert Mitchell, Karl Muench, Darla Lorber, J. C. Molina

ACTION ITEMS:

- Social Committee Chairman Charlotte Howard will schedule a spring Board of Directors meeting and a summer Social Event for the neighbordhood. The treasury can be used to purchase part of the food for a neighborhood event.
